

Rules for students with physical disabilities and chronic diseases

Art. 1. These Regulations for students with physical disabilities and chronic diseases contains rules that must be met to ensure proper conditions for training and education of their BIOTERRA University Bucharest (BUB).

Art. 2. The administrative staff of BUB will deal with providing material conditions, physical, facilitating access for students with physical disabilities.

Art. 3. In this respect, building access ramps in buildings where classes are conducted with students with physical disabilities, their number is required.

Art. 4. Before BIOTERRA University Bucharest, will establish parking for cars students with physical disabilities and the chronically ill, their number is required.

Art. 5. Students with physical disabilities will be informed about the various news of the educational process, examination of extracurricular activities at a special bulletin board built at a height accessible information to be read by them.

Art. 6 courses and other educational activities with students with physical disabilities is organized in rooms located at the ground floor BIOTERRA University Bucharest.

Art. 7. held within the university a first-aid station, a first aid kit, especially for chronic patients (eg. AIDS etc.).

Art. 8. Students with physical disabilities and those with chronic diseases may, upon request, advisory services pedagogical, educational and career guidance within the Department of Professional Orientation Students.

Art. 9. methodology for pedagogical advisory services, educational and career guidance are both individual and group.

Art. 10. The methods applied in the pedagogical counseling services, educational and career guidance to students with physical disabilities and those with chronic diseases are interactive, such as group discussion, the workshop interactive role play, lecture - dezbatere, heuristic conversation, brainstorming, etc., depending on the ability of the student.

Art. 11. As individual activities within the pedagogical counseling services, educational and career guidance, students with physical disabilities and those with chronic diseases can complement professional skills tests, questionnaires professional interests, letters of intent, form submissions group counseling and coaching, counseling student forms etc., according to their means.

Art. 12. Students with physical disabilities and those with chronic illnesses may benefit, on request, consultations specialized in the Department of Professional Orientation Students.

Art. 13. pedagogical counseling services, educational and career guidance, specialist consultations are given to students with physical disabilities in a furnished room on the ground floor of a building BIOTERRA University Bucharest.

Art. 14 are involved in specialized consulting services all teachers on a schedule agreed with students with physical disabilities and those with chronic diseases, according to their needs.

Art. 15. Teachers of students with physical disabilities and those with chronic diseases will provide them with personal phone number and e-mail, to a very good communication staff.

Art. 16. Counseling pedagogical, educational and career guidance is carried out by a teacher, doctor in Educational Sciences (Psychology, Teaching) or Psychology.

Art. 17. The teacher involved in advising pedagogical, educational and career guidance will provide students with physical disabilities and those with chronic illnesses personal phone number and e-mail, to a very good pedagogical communication and staff.

Art. 18. Students with physical disabilities and those with chronic diseases are beneficiaries of projects and extracurricular activities that help them in their professional development in their career.

Art. 19. Students with physical disabilities and those with chronic diseases can benefit from health maintenance devices by moving in specially equipped gym (fitness).

Art. 20. Students League will be involved in supporting their colleagues physically disabled and those with chronic diseases by referring counseling and expert advice.

Art. 21. Tutors year will have their track students with physical disabilities and those with chronic diseases will assist in delivering assistance, as required.

Art. 22. tutors year will have their track students with physical disabilities and those with chronic diseases and will assist in delivering assistance, as required.

Art. 23. The special cases of students with physical disabilities and chronic diseases can benefit from social grants.

Art. 24. Students with physical disabilities and those with chronic diseases, depending on the severity and specifics of each case, mobility can participate in cultural, educational, sporting mutual students from other countries.

Art. 25. Students with chronic diseases through a request to the Dean, can I get the time of examination during examination sessions whatever type examination.

Art. 26. Students with disabilities other than those locomotorii or those with chronic diseases, can get a written request addressed to the Dean, help with writing ideas on paper, all written examinations, ajutantul not having allowed to interfere in the student show .

Art. 27. It is forbidden to discredit any form of all students including students BUB and physically disabled and those with chronic diseases.

Art. 28. All teachers have class students with chronic diseases will adapt their teaching methods so that no student is disadvantaged category.
