Original language [EN]

One of the key points of the Charter of the Bioterra University of Bucharest (BUB), the mission of the university and the strategic plan 2018-2022 is the internationalization of the university. Yes, it is a key point in the university's medium and long-term development.

A full-time graduate of our university possesses not only competencies, knowledge and abilities through which it is able to respond to the challenges of a dynamic labor market but also intercultural competencies that make it easier to integrate into different groups with known cultural characteristics.

The process of internationalization is very complex in which the whole academic community is involved and different fields interact and condition each other somewhat. These areas refer to:

- a)Improving analytical programs and curricula for all university studies programs in order to increase compatibility with similar international study programs and future graduates to be easier to integrate into a dynamic national and international labor market.
- b)Involvement of the academic community for the achievement of internationally recognized results that are the product of the academic research and academic collaboration of the University with foreign partners.
- c)Developing English-language programs that have the immediate aim of recruiting foreign students.
- d)Increasing the number of participants in the mobility of students and teaching staff as well as improving recruitment procedures for foreign students.
- e)The qualitative and quantitative increase in the number of partnerships and services as well as the development of external relations.
- f)Ensure a greater number of extracurricular activities.

To improve the analytical curriculum and the curriculum of a study program as well as the competencies offered, BUB assesses the compatibility of that program both formally and structurally with study programs both in the European educational space and outside the European Union. The Bologna model is the one used by every university in the country, so by BBU. The key points to be considered to ensure compatibility are:

- -time of the study cycle;
- -time for one semester for each course;
- -the use of a credit system with transferability (ECTS) implemented in BUB;
- -the presence of compulsory and elective courses;
- -offer a significant number of elective courses;
- -conducting research activities in parallel with academic efforts (similar to valuable programs in Europe and non-EU countries) and the use of modern scientific and research methods and results in the field concerned;
- -admission requirements (requirements, procedures), transfer conditions for the following year;
- -acquiring the diploma and addressing the learning process;

Improving analytical programs and curricula is the main objective of each faculty, but the university will always ensure a close interaction and communication between faculties.

In order to increase the international visibility of the institution, BUB has been one of the major objectives, developing a competitive research to achieve recognized national and international results. Individuality is important on the one hand but, on the other hand, the Departmental Councils have an essential role. In BUB's strategic plan lists some of the sources of funding identified but always "the list remains open".

BUB has proposed to develop study programs in English to increase the visibility of the institution, its internationalization by recruiting foreign students. We can say that this is a step forward in increasing the number of participants in the mobility of students and teaching staff. The three programs in English are: a) Applied Computer Sciences; b) General Medical Assistance; c) European and International Law. The three programs received a positive opinion from a German accreditation agency - AHPGA.

Mobility for educational purposes aims at increasing the professional, social and intercultural competencies of the beneficiaries of education. Starting from this goal as well as from the previous partnerships, BUB is interested in signing strategic partnerships with universities and international companies in the EU but also other enterprises, research entities, social partners, other than traditional partners.

The university is particularly interested in "triforms" partnerships that combine higher education, research and business for regional excellence and growth. The new vision of BBU and the development of the three English-language programs make the university orientated towards partnerships with non-EU companies or universities in Asia, Latin America and Africa, so that the visibility of the institution grows. Teachers from universities belonging to these continents will be invited to BBU to develop mobility strategies and bilateral exchanges of students and staff.

Using the geographic position, the university will intensify cooperation with universities or institutes in Italy, Turkey.

#### Original language [EN]

The Bioterra University of Bucharest (BUB) strategy on the organization and implementation of international cooperation projects (EU and non-EU) is based on the main objective of the university, namely the internationalization. The University assumes the role it intends to play in strategic partnerships with prestigious universities (e.g. the University of Florence, Gedik University, etc.) as well as partners from the geographical priorities and the priority areas (The Mediterranean Agronomic Institute of Chania - Greece, The High Institute for Specific Studies, El-Giza, Cairo, CNR-ISE, Institute of Ecosystem Study, Pisa, Italy).

International cooperation projects will take into account the following:

- -establishing cooperation objectives
- -clarifying role in the project and expected results
- -development of the BUB strategy of modernization and internationalization
- -analysis of specific needs
- Allocating the resources (time, finances, administrative back-up, study programme accreditation procedures). BUB is committed to implementing the results obtained by participating in these projects either as a long-term strategy or as a short-term strategy. BUB is committed to fully supporting any student and staff in such projects and is an important component of professional development and staff assessment.

Original language [EN]

The modernization of the Bioterra University of Bucharest (BUB) through internationalization is the premise of continuing and accelerating the efforts of the university in this direction. All activities offered through the Erasmus+ program, starting with the participation of students, academic and / or administrative staff in bilateral projects with EU or non-EU partner institutions, or mobility of students, teaching and / or administrative staff, result in an increase of the quality of the higher education within the BUB as well as increasing the number of research competencies that are tested in the international environment and which could be implemented in all BUB Departments and other partner institutions.

The signing of the Erasmus+ Charter by Bioterra University of Bucharest has as a starting point the assumption by the University of the Agenda for modernizing the higher education system in Europe and pursuing the following objectives:

- 1. Increasing the quality of the educational process by taking concrete measures. BUB participation in the Erasmus + program implies the improvement and modernization of curricula, more effective evaluation methods, a higher level of staff exchange and a more active exchange of knowledge and expertise, wider intercultural management of ideas and a true multicultural approach of values, common degrees and partnerships. The finality of this approach is to increase the number of higher education graduates that will contribute significantly to Europe's needs.
- 2. Improving the relevance of higher education as well as adapting / redefining research interests, introducing common master's programs or doctoral programs. The result of all these actions is to assist in combining a very qualitative educational process with immediate positive impact on the entire academic community. The finality of this approach is to increase the knowledge and transferable skills of graduates that will be able to respond positively to a labor market in the process of dynamism.
- 3. A superior quality of the process on mobility and cross-border cooperation, the main bind in BUB internationalization. The main actors in this complex process, whether they are students or teaching or administrative staff, can improve their language skills and cross-border cooperation contributes to building a common set of values, sharing experiences and developing the personalities of all participants.
- 4. Improving the theoretical and practical knowledge, the skills accumulated by the learners at all levels of education make them competitive graduates for a local, regional, European or global society, in full dynamics.
- 5. Funding is another major objective of the BUB. The Erasmus + program is expected to be one of the sources of funding for students, academics or academic staff as well as a form of academic development.

Obtaining the Erasmus + Charter would be for the BUB to bring all the efforts of the university into the process of internationalization, modernization and an open door for the mobility of students, teaching or administrative staff.

The credit units specific to each discipline are specified in the curricula of each university study program as well as in the characteristic syllabus.

In order to increase the workload required by each student, the following equation is respected according to the legal standards in force: 1CP = 25 hours. For each BUB Bachelor's degree program, each student earns 240 ECTS (60 CP per year \* 4 years = 240 ECTS) as a result of the exams stipulated and promoted in the curricula respectively 90-120 ECTS (60 HP per year \* 1.5 / 2 years = 90/120 CP) within the Master's Degree Program. The successful completion of the bachelor / diploma / master's thesis is valued with 10 ECTS added to the 240 ECTS previously accumulated by each student and respectively 90-120 ECTS previously accumulated by each MA.

For BUB students participating in mobility, they will present at the return from foreign countries a recognition form specifying the study period, courses and related ECTS. This form is validated by a commission decided by the faculty dean. After validation, this form will appear in all academic papers of the student as well as in the Diploma Supplement.

All this information is specified in the "Regulation for the Application of Transferable Credits ECTS - 2018", a regulation approved by the Senate BUB.

Prior to Erasmus mobility, students must sign the Learning Agreement, which must then be approved by the Erasmus + Coordinator of the Faculty and the Erasmus+ Institutional Coordinator for both the home university and the host university. For teachers, they must sign the teaching or training programs in which should be specified the number of teaching hours or other significant activities. These documents are concluded on the basis of the Erasmus interinstitutional bilateral agreements.

In order to conclude an institutional bilateral agreement, the entire BUB academic community may participate, if the agreement is in line with the development strategy of the department or faculty where the person proposing the agreement belongs and whether there is compatibility in case of study programs belonging to the main actors (the two universities) of the agreement. After being approved by the Faculty Council and the Board of Directors of the BUB, the agreement is registered at the Erasmus + Office, which provides for the preparation, organization and monitoring of the mobility that will be carried out under the agreement, with the direct support of the Faculty Council and the Erasmus + Coordinator of the Faculty.
